#### Program Update: Medicare Minute

In September 2013, the Medicare Rights Center secured a 17-month grant from the federal Administration for Community Living (ACL) to launch a program—through partnerships with nationwide Senior Medicare Patrols (SMPs) and disability-serving organizations—that would implement the Medicare Minute program in new locations across the country. The goal of the SMP Medicare Minute program is to empower people with disabilities to take control of their health care and combat fraud.

The SMP Medicare Minute builds on Medicare Rights' 13 years of experience developing and distributing traditional Medicare Minutes, short, monthly scripts that volunteers in communities across the country use to educate and engage their peers in conversations about Medicare. Today, Medicare Minutes reach an estimated 95,000 individuals each year with timely Medicare information.

Now, through the SMP Medicare Minute program, the Medicare Minute model has undergone a significant expansion and transformation, with presentations now including tips for preventing Medicare fraud, and content tailored specifically to serve people with disabilities.

Thus far, Medicare Rights has launched the SMP Medicare Minute program in 20 states, including Kentucky, Alaska, Iowa, Maryland, and Maine. Our state-based SMP partners engage volunteers who go into their communities each month to lead Medicare Minutes, fielding questions and building audience confidence in their ability to navigate their Medicare coverage. Popular Medicare Minute topics of late have included: "The Affordable Care Act and Medicare", "Part D Appeals", and "Durable Medical Equipment". Through this project, intended to serve people with disabilities nationally, Medicare Rights has also cultivated partnerships with national and local disabilityserving organizations, connecting SMPs with local chapters that could be good sites for SMP Medicare Minute presentations.

certain core areas of focus, including: network adequacy, plan payment and performance measures, stakeholder and beneficiary engagement, appeals and grievance procedures, and ombudsman programs.

Medicare Rights continues to work to advocate for important protections and increased quality of care for people eligible for both Medicare and Medicaid, also known as dually eligible. In July 2012, Medicare Rights formalized this work with a grant from the New York State Health Foundation to create a coalition to engage in advocacy for individuals eligible for dually eligible New Yorkers. The Coalition to Protect the Rights of New York's Dually Eligible (CPRNYDE), led by Medicare Rights, now has over 40 organizational members and a strong Steering Committee.

Additionally, with this funding, Medicare Rights created and maintains a Coalition website: www.nyduals.org. The website allows advocates both in New York and in other states implementing managed care programs for dually eligible individuals to gain insight on the advocacy Medicare Rights leads in New York.

Last summer, Medicare Rights' work with the coalition was further expanded through a grant from Community Catalyst, which named New York as one of the states under its Voices for Better Health Project. Under this grant, the Coalition has been able to drill down its advocacy to

Medicare Rights has also received support from the Altman Foundation to create educational materials for dually eligible individuals and the professionals that work with them most closely. Medicare Rights will also continue to lead the Coalition to Protect the Rights of New York's Dually Eligible in advocacy with the Department of Health and CMS around FIDA's implementation and the continued rollout of MLTC throughout New York.

#### Medicare Rights Welcomes New Board Member



This month at its annual meeting, the Board of Directors of the Medicare Rights Center elected a slate of directors and officers for the coming year, including a new member, Jonathan Blum, the former Principal Deputy Administrator and Director for the Centers for Medicare

and Medicaid Services (CMS) overseeing the Medicare program.

As the top Medicare official at CMS, Blum was responsible for overseeing the regulation and payment of Medicare fee-for service providers, privately-administered Medicare health plans, and the Medicare prescription drug program. He

served as an advisor to Senate Finance Committee members and former chairman, Senator Max Baucus, where he worked on prescription drug and Medicare Advantage policies during the development of the Medicare Modernization Act. He also served as a program analyst focused on Medicare at the White House Office of Management and Budget. Currently, he is the Executive Vice President for Medical Affairs at CareFirst Blue Cross, which provides health care coverage in Maryland, the District of Columbia and Northern Virginia
